

#### Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement

Participation in activities at Three Sisters Farm, LLC is voluntary. You must exercise caution in any activity you participate in and follow all instructions given by any signs or personnel on site.

#### Warning:

Under Mississippi law, there is no liability for an injury to or death of a participant in an agritourism activity conducted at this agritourism location if the injury or death results from the inherent risks of the agritourism activity. Inherent risk of agritourism activities include, among others, risks of injury inherent to land, equipment and animals, as well as the potential for you or another participant to act in a negligent manner that may contribute to your injury or death. You are assuming the risk of participating in this agritourism activity.

- The Three Sisters Farm, LLC provides the opportunity for Participants to engage in various agritourism activities, farm animal activities, equine activities and other activities.
- An 'agritourism activity' is any activity carried out on a farm or ranch that allows members of the general public, for recreational, entertainment, or educational purposes, to view or enjoy rural activities, including farming, ranching, historic, cultural, harvest-your-own activities, or natural activities and attractions. An activity is an agritourism activity whether or not the participant paid to participate in the activity.
- By participating in agritourism activities or equine activities, or any other activity at Three
  Sisters Farm, LLC, you are assuming the risks of said activities. Participation in these
  activities is voluntary, and done at the sole responsibility of Participant. Three Sisters Farm,
  LLC is not liable for injury to or death of a participant resulting from the inherent risks of
  agritourism activities, equine activities or any other activity.
- By execution of this Agreement you agree that Three Sisters Farm, LLC shall not be liable for any
  injury or loss to person or property that the Participant may sustain while participating in agritourism
  activities, equine activities, or any other activity at Three Sisters Farm, LLC.
- You hereby release Three Sisters Farm, LLC from any liability whatsoever for any personal injury arising out of participation in agritourism activities, equine activities, and any other activity at Three Sisters Farm, LLC.
- In exchange for participation in agritourism activities, equine activities, or other activities at Three Sisters Farm, LLC you agree that Three Sisters Farm, LLC is hereby released, waived and discharged for any liability, claim and/or cause of action arising out of or related to any loss, damage, or injury, including death, that may be sustained by the Participant as a result of participation in said activities at Three Sisters, LLC, and this document shall be deemed as a covenant not to sue Three Sisters Farm, LLC for the same. You further agree to indemnify and hold harmless Three Sisters Farm, LLC from any loss, damage, or injury, including death, resulting from said activities at Three Sisters Farm, LLC, whether such injury or loss is the result of Participant's negligence, negligence of Three Sisters Farm, LLC or the negligence of any third party.
- This Agreement shall be binding upon any of Participants heirs or personal representatives of Participant's estate, and to any successor and/or assign of Three Sisters Farm, LLC.
- This Agreement, and any matter arising out of or related to this Agreement, shall be governed by the laws of the State of Mississippi. This Agreement shall be construed as a release and waiver to the maximum extent permissible by Mississippi Law.
- I acknowledge that I am fully aware of the legal consequences of entering this Agreement, and that I do so after consulting with counsel (or that I otherwise waive the opportunity to consult with counsel).
- I acknowledge that I have no physical or emotional condition which could interfere with my participation in agritourism activities, equine activities, or any other activity at Three Sisters Farm, LLC, and that I am capable of safely participating in said activities.
- I agree and consent that there may be photographs and/or videos taken of Participant while at Three Sisters Farm, LLC. Three Sisters Farm, LLC shall hold the exclusive copyright to any such photograph and/or video. Said photographs and/or videos may be reproduced, sold, or otherwise used by Three Sisters Farm, LLC in promotional materials, social media, its website, or other media. I release Three Sisters Farm, LLC from liability for any violation of personal and/or proprietary right I may have in connection therewith.
